

## **Act to Promote Housing Choices Needed Now More than Ever**

### **RE: House 4263 - An Act to Promote Housing Choices**

Dear Senator Creem and Representatives Balser, Khan and Lawn:

We are writing as a group of elected officials, community organizations and concerned residents who want Newton to become a more inclusive, diverse and sustainable city. We know that Newton needs to create more multifamily, mixed-income housing so that families with children, seniors needing to downsize, our grown children just starting out in their careers, and people who work in Newton will be able to find affordable and appropriate housing. Without it, we will lose these people, our local economy will suffer, and we will be unable to fulfill our goal of creating a community of opportunity.

However, current state law has been a significant roadblock to the production of exactly the type of housing that we so desperately need. Under state law, zoning changes and special permits require a 2/3 vote. In Newton, the special permit granting authority is the City Council, and with a 24-member City Council, achieving this threshold has been very challenging.

In Newton, the permitting process for multifamily housing developments has typically taken more than two years and in some cases far longer than that. Clearly, this lengthy process has significantly slowed down the rate of much-needed housing production and added barriers to the process, rather than removing them.

At this juncture, Newton needs assistance from the state to allow us to create the housing we need. H.4263, *An Act to promote housing choices*, would enable a municipality to pass by a simple majority vote certain zoning changes that would help advance housing production and smart growth development, as opposed to the currently required super majority (2/3) vote. The bill would also allow a simple majority vote to approve certain special permits for affordable housing developments around public transit or in mixed-use developments. Passing this bill would be a significant step towards meeting Newton's critical housing needs, allowing local communities to contribute to housing production.

Despite the barriers posed by the current process, in the last several years, Newton has worked hard to do its part to contribute to new housing production. Most recently, in December 2019, the City Council granted a special permit to the Northland development on Needham Street, which will add 140 permanently affordable units to our housing stock. On March 3, 2020, the Council's Northland decision was upheld by Newton voters by a margin of 58% to 42%, affirming Newton's vision to create more housing opportunity.

While we are proud of this decision and the referendum to affirm it, the 2/3 supermajority remains a barrier to the efforts in Newton and other communities to create multifamily housing. Changing the threshold to a simple majority would allow Newton and our surrounding communities to produce more housing and more affordable housing in a timely manner. While this change will not solve all of our housing problems, it will generate much needed momentum and begin to create the more inclusive, diverse and sustainable city we know we can achieve.

Particularly in this time of COVID-19, it is clear that the importance of creating housing opportunity for all has never been more important. In fact, our collective health depends on safe and affordable homes for all.

For these reasons, we urge you to support H. 4263. We ask that each of you let us know by May 29, 2020 whether you will support the bill, by emailing your response to Judy Jacobson at [judyjacobson@rcn.com](mailto:judyjacobson@rcn.com). Thank you for your consideration.
